

RESOLUTION NO. 16-01

A RESOLUTION OF THE CITY OF PANAMA CITY BEACH AUTHORIZING THE TEMPORARY CLOSURE OF CERTAIN SECTIONS OF NORTH RICHARD JACKSON BOULEVARD, NORTH ALF COLEMAN ROAD AND MARKET STREET TO PERMIT THE J.R. ARNOLD HIGH SCHOOL HOMECOMING PARADE ON OCTOBER 23, 2015.

WHEREAS, the J. R. Arnold High School Homecoming Parade will be held on Panama City Beach; and

WHEREAS, the Homecoming Parade has been scheduled for Friday, October 23, 2015; and

WHEREAS, the occasion necessitates careful traffic control and extraordinary usage of certain sections of North Richard Jackson Boulevard, North Alf Coleman Road, and Market Street within the corporate limits of Panama City Beach;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL of Panama City Beach that, during the hours of 12:30 P.M. and 2:00 P.M., on October 23, 2015, certain sections of North Richard Jackson Boulevard, North Alf Coleman Road and Market Street shall be temporarily closed to permit the J.R. Arnold High School Homecoming Parade, and all vehicular traffic shall be controlled in accordance with the map which accompanies this Resolution.

This Resolution shall be effective immediately upon passage.

The Permittee shall be responsible to maintain the portion of the state road it occupies for the duration of this event, free of litter and providing a safe environment to the public.

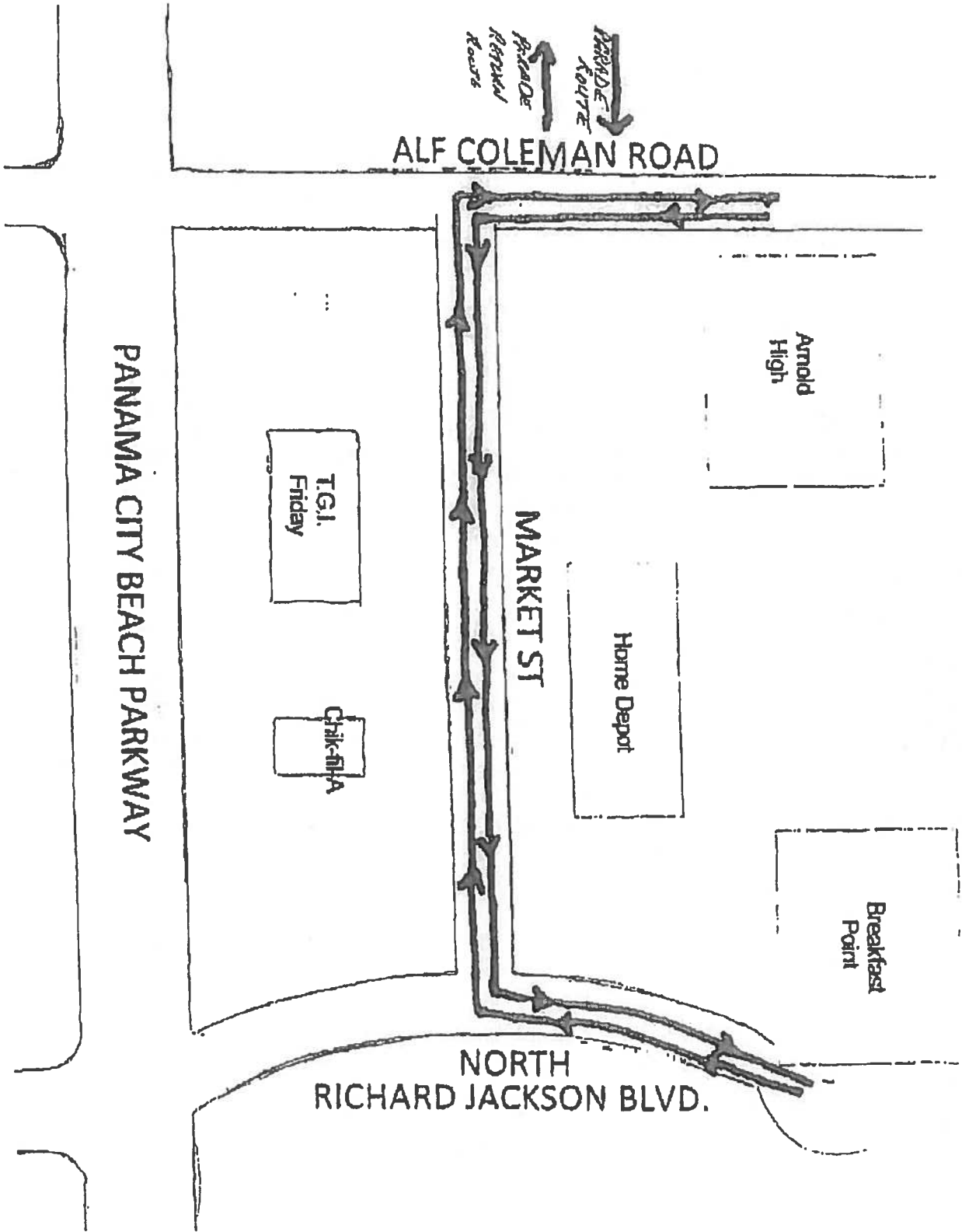
